Step One: Lien Holder Record Search/OSHP Inspection Request

WHERE TO GO: Ashtabula County Clerk of Courts Title Office

- Complete the Lien Record Request form and return it to the Ashtabula County Title Department to inquire about and obtain any applicable lien holder information for the vehicle being petitioned
- •Obtain a completed Ohio State Highway Patrol Inspection Request form
- FEE: a \$5.00 record search fee will apply for each title record search
- Please make checks payable to: Ashtabula County Clerk of Courts
- Retain Lien Holder Record Request results from the Clerk of Courts Title office to file with your petition as a necessary exhibit
- Retain completed Ohio State Highway Patrol Inspection Request form for Step 5

Step Two: Vehicle Owner Record Search

- Click on More Services
- Click on **BMV Record Request**
- Check the Terms and Conditions, captcha and continue
- Fill out the **Requester** info; How you would like the results delivered to you and whose record are you requesting fields. A pop-up box will appear if email was chosen. Please click that you agree.
- Record type will appear and you must check the type of **Certified Ohio BMV Record** that you are requesting or **Vehicle Registration/Title Records option**
- Next fill out the **Identifier** section and **continue**
- Next choose the **Reason** that you are requesting records
- Review the information that you selected, add to cart, check out, Review order and payment.

- The BMV will email or mail a BMV 2433 form to you containing the results of the record search
- Please allow at least 15 business days for processing
- **FEE**: a \$5.00 record search fee will apply for each title record search
- Retain BMV 2433 form to file with your petition as a necessary exhibit

Step Three: Certified Mail Notifications

- Mail a Certified letter to the vehicle owner(s) and lien holder(s) using the information provided by the BMV and Clerk of Courts title office notifying them of your intention to petition the Court for a certificate of title
- Please allow 15 days from the date of mailing for appropriate parties to respond back to you.
- Retain copies of:
 - -the letters mailed
 - -the returned certified mail receipts
 - -and any responses to file with your petition as a necessary exhibit

Step Four: Obtain Ohio State Highway Patrol Vehicle Inspection Receipt

- Visit any Ashtabula County License Bureau office to purchase an Ohio State Highway Patrol Vehicle/Salvage Inspection Receipt
- **FEE**: \$55.00

*** The Vehicle Inspection Receipt is also referred to as the Salvage Inspection Receipt and is required for ALL vehicles***

Step Five: Schedule your OSHP Salvage Inspection

- Retain the OSHP 106 Form you are provided to submit with your petition as a necessary exhibit
- *** The vehicle inspection is also referred to as a Salvage Inspection/Court

 Order Inspection and is required for ALL vehicles***

Step Six: File your Petition/Affidavit and Judgment Entry with the Ashtabula County Court of Common Pleas

- <u>FEE</u>: Filing fee of \$30.00 (After approval or denial, court costs will be figured and applied from the deposit money and any overage will be returned to you)
- •A miscellaneous civil case will be opened when you submit an original and two copies of the following: -a notarized petition/affidavit (included in packet)
- -unsigned Judgment Entry (included in packet)
- -Completed Ashtabula Clerk of Courts Title Dept Lien Record Request Form (from Step 1)
- -Completed BMV 2433 Form (from Step 2)

- -Completed OSHP 106 Form (from Step 5)
- -copies of any Certified mail notifications and receipts
- -All relevant documentation (i.e., proof of attempt to contact owner of record, copies of past insurance and/or motor vehicle registration, copies of checks or receipts to show payment made for motor vehicle, and any other documents to support ownership) needs to be attached to the petition/affidavit at the time of filing.

Step Seven: Appear before a Common Pleas Court Judge

WHERE TO GO: Common Pleas Court

• After you file the petition and supporting evidence an oral hearing will be set for the judge to consider your documents. If your petition is granted, the Judge will sign the Judgment Entry and direct you to the Clerk of Courts Legal Department

Step Eight: File your Judgment Entry in the Clerk of Courts office

• Once filed, you will be given a certified copy of the Judgment Entry to present to the title office for your certificate of title

Step Nine: Return to Clerk of Courts Title office to make an application for certificate of title

- Bring certified copy of the Judgment Entry and a valid photo identification card to the Title office to apply for a certificate of title
- **FEE**: Title fees and applicable sales tax apply
